

# Minutes of the June Meeting

- President Rick Munzer called the meeting to order at 10:00 am.
- Rick introduced visitors and new members: Vivian's daughter Jane is visiting; Roland McCollogh,
   Columbia resident with lifelong interest in woodworking, told about Guild by a friend.
- President Rick Munzer announced that the Guild needs a shop coordinator to coordinate shop monitors, to keep shop open on Wed, Thurs, and Fri. It is a requirement of the County that we have a shop
  - monitor. The position involves coordinating with the Bain Center and the monitors to make sure the shop is covered and being used safely. It is essential that we have this in place. Interested parties should see Rick.
- Gene Torrey provided a demonstration of making bandsawn boxes.
- Treasurer's report by Manny Flecker: \$5992.63 currently in the bank, and this will rise as the new dues are accrued.
- Membership Report by Gene Torrey: Dues are due for 2015-2016. See notes in "Guild Announcements," below. Some changes have been made to navigation of the website, in response to suggestions from members. The handbook portion will be made public, though the private
  - contact information will remain private. The membership listing used to be sent out via email. Gene will see about getting an updated list out soon. The Guild will no longer mail information to anyone because of the expense and labor involved, but all membership information, etc. is freely available via the Guild website. There was a brief discussion of website security and privacy.
- President Rick Munzer made a plea for demonstrations starting in September. People do not need to be experts to present a project or technique.



- Member Ed Fisher encouraged people to volunteer as a shop monitor. It is an opportunity to learn from
  the people who are working in the shop, as well as serving the Guild. There was a suggestion to have
  alternative shop monitors; the Guild already does this. Rick made another appeal for shop monitors
  who will be able to be aware of safe use of the shop. Ed Fisher will be happy to arrange for training
  new shop monitors.
- A former Guild member has a tree farm near Winchester, VA. He has about 100 bdft of spalted sycamore, at \$4 per bdft. Contact Ed Fisher if interested.

**Shop Monitors Needed:** Several shop monitors are currently needed or will be in the near future. Unless a designated monitor is present, the shop in the Bain Center cannot be opened. Contact Wayne Austin if you are interested in helping in this capacity or to obtain additional information.

**Monthly Demonstrations:** In the past, a HCWG member who gave a demonstration was given a dues free membership for the following year. Effective July 2013, HCWG members will be reimbursed at the same rate as outside demonstrators: \$100.00. This is for a 45-60 minute demonstration. When multiple members join

together to give in effect several mini demos, the reimbursement will be split among the individuals as agreed by the individuals concerned. This reimbursement **will not** be applicable to events such as "jig/fixture-arounds".

Scheduling these highlights of our monthly meetings is not an easy task. An elaborate machine-based demo is not the only way to go. The assembly of a project you have underway and explaining how you got the parts to their current size and shape is okay. An explanation of how and why various joints are used, which adhesives or fasteners work best in a particular application are of interest to all members. How about what you do? Do you have an interesting or different woodworking technique? Something that you know how to do well and think other members may be interested in learning? The way you approach a certain function may be an eye opener to everyone else. There is no single right way for most of our woodworking tasks and each of us can learn something new if given the opportunity. Or, do you know someone who does woodworking who might come as a guest and do a demonstration? The giant TV screen now available is a great method for presenting slide shows although some specific formatting rules must be used. #### June Demonstration

Gene Torrey, the Guild's Webmaster and Membership Chair, demonstrated how to make bandsawn boxes. Gene thanked Harold for videotaping and the "guys" for bringing out a shopvac. Gene showed a short video on bandsawn boxes that he used as an inspiration for himself. The video showed the basic steps of construction.

Gene uses 3/16" blades from Carter Blades. His preferred blade has 10 teeth per inch in order to get a smoother cut than the typical 4 tpi. Gene has made some mods to his 14" imported bandsaw, including a higher tension spring for the blade tension (also from Carter). Gene elected to swap the friction blocks for a upper and lower roller bearing arrangement from Carter, about \$150. Gene did a lot of work to properly set the guides on his saw. He also set the saw's drive belt on the slower pulley to reduce the blade speed.



Gene's demo used a 6"x6" block of solid redwood. To start the box, Gene cut off a %" back slice. Gene prefers to cut the back off the rectangular blank first. He likes that this provides a flat back for cutting the profile. He cuts the back off and marks it to make sure he can align the pieces correctly later for reassembly. Gene then cut out the outside profile of the box by following the pencil line he created from his template. (There was a suggestion from audience to chamfer the back edges






The grain in this blank is vertical, so Gene makes the entry cuts for the drawers vertically at one corner of the opening so that the re-glued cut is less visible in the grain. He enters from the bottom and cuts up one side to the top drawer first. He then works down the blank to the 2nd and 3rd (lowest) drawer in order, not pausing to remove the drawer blanks. Gene uses the lines on his blank for drawer outlines as "suggestions" - it is essentially a freeform cutting process.

Gene then adjusted the saw's fence to cut a slice off the face of each drawer blank. He prefers to cut the face off of all three blanks at one time. Gene marks the back of each drawer so that he can quickly realign the face for reassembly. He then reset the fence and cut a slice off the back of each

drawer, also marking them for easy reassembly.


(Questions were voices about setup of guides and blade: the blade teeth must stick out in front of the side rollers to work properly, so that the rollers will not interfere with the set of the blade's teeth. The side rollers need to be in very close contact with the sides of the blade to maintain a stable cut).

For the next step, Gene checked and marked the top of each drawer blank so that he will cut the inside of the drawer properly from each blank. The drawers do not work well if one cuts the cavity out of the drawer's bottom! (We did not ask how Gene knows this...) Gene cut the centers out of all three drawers. The remaining steps are gluing, sanding, and finishing (not demonstrated).



Gene says that a back/front slice thinner than % creates a risk of the wood warping. This might not be an issue with fully dry hardwood. He has used felt on the inside of drawers, and would like to try flocking.

Gene responded to many questions, comments, and suggestions from an appreciative audience.

# Safety Eye Protection: Are My Prescription Glasses Good Enough?

Many woodworkers who wear eyeglasses use their regular prescription glasses in the shop as their safety glasses. But, are they compromising safety by doing so? The answer is: Perhaps.

It is important to understand a few essential differences between true safety eye protection and typical prescription eyewear:

- Normal eyeglasses may be relatively small in size and will almost never include protection to the side of the eye. This greatly limits the area of coverage/protection provided.
- Prescription eyeglasses, even when they include scratch-resistant coatings, are vulnerable to scratching/scuffing from airborne abrasive debris in the shop. While this is not directly a safety issue, the cost of a pair of prescription glasses, compared to the cost of a pair of safety glasses, should be considered.
- Normal prescription glasses may not have to meet the same impact standards as ANSI-approved high impact safety glasses. This is true in two respects: the amount of impact the lens must withstand may be lower. Second, safety glasses must be tested as a complete system: frame and lenses together, while typical prescription eyewear need only pass (lower) impact tests for the lenses independent of the frame. True safety eye protection must meet a "high impact" test where a ¼" steel ball is shot at the lens-and-frame system multiple times from multiple angles at 150 feet per second. That's 102 mph, which is a pretty good clip but not unrealistic for a chunk hurled by a spinning tablesaw blade. High impact safety eye protection products must also withstand a "high mass" impact test where a 17.6 oz (more than a pound) steel ball is dropped from a height of 50 inches. Products that meet these standards must be marked "ANSI Z87."

ANSI-rated full safety goggles provide the most complete eye protection. However, many people find goggles to fog up easily and to be uncomfortable. Newer safety glass products have improved comfort a great deal, but the protection-comfort balance can remain an issue.





What is the best solution? High-speed turning or regrinding a plane blade on a bench grinder probably require a higher level of eye protection than handplaning a board. Think about eye protection for any shop task you are doing, keep a range of eye protection solutions available to match the risk, and then <u>use them</u>.
